To continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets:

- Implementation of car share between two office members in Beaumont House.
- Every other management meeting conducted online preventing the requirement to travel.

We project that carbon emissions will decrease over the next five years to 5.2 tCO₂e by 2029. This is a reduction of 26%.
